### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is the Product?

#### Type

Cyprus law governed over-the-counter (OTC) equity derivative transaction linked to the worst performing share among those set out below with 'autocall' and 'memory coupon' features. Forms of contract documentation governing this type of transactions can be found at: <http://bcs-sp.com/otc/>. You may invest not less than USD10000 in the product.

Under the applicable laws and regulations of the Republic of Cyprus it may be required for you to enter into OTC derivative transactions with Brokercreditservice Structured Products Plc through a duly authorized and regulated investment firm BrokerCreditService (Cyprus) Ltd acting as agent for and on your behalf (**intermediary**). Brokercreditservice Structured Products Plc does not guarantee that any intermediary will agree to act for and on your behalf in entering into any such transactions.

#### Objective

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) a cash payment or delivery of the **worst performing share** (as defined below) on termination of the product. The timing and amount of these payments will depend on the performance of the underlying shares. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If, at maturity, the worst performing share's **current price** (as defined below) has fallen *below* 75% of its **initial price** (as defined below), you will receive the worst performing share in its **delivery volume** (as defined below) and, consequently, **LOOSE UP TO YOUR ENTIRE INVESTMENT**.

**Coupon.** If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* 75% of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to 18% per annum on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupon(s) for the previous period(s).

**Early termination following an autocall.** The product will terminate prior to the maturity date if, on any event determination date, the current price of each underlying share *is at or above* 100% of its initial price. In such case, you will, within two (2) business days following that event determination date, receive, in addition to any final coupon, a cash payment equal to the amount of your investment. No further payments will be made on any date after such event determination date.

**Termination on the maturity date.** If the product has not terminated early, on the maturity date, you will receive:

- (1) if the worst performing share's current price *is at or above* 75% of its initial price, a cash payment equal to the amount of your investment; or
- (2) if the final reference level of the worst performing share is *below* 75% of its initial price, the worst performing share in its delivery volume.

**Potential adjustment events.** If during the lifetime of the product a split, consolidation or any other event having a diluting or concentrative effect on the theoretical value of the relevant underlying share occurs the terms of the product may be correspondingly adjusted and you will be duly notified of such adjustment.

**Extraordinary events.** If during the term of the product any extraordinary event (such as nationalization, insolvency or delisting) occurs in respect of an issuer of any underlying share, such share's current price in respect of any date for the purposes of the product shall be decreased by 30%. Consequently, due to an extraordinary event you may **LOOSE UP TO YOUR ENTIRE INVESTMENT**.

<b>Current price:</b>	The closing price of an underlying share as of an event determination date, maturity date or early termination date
<b>Delivery volume:</b>	In respect of each share - the amount of your investment divided by product of Exchange Rate (as defined below) and 100% of such share's initial price
<b>Exchange Rate:</b>	The rate of conversion between the currency of the Worst performing share and the USD
<b>Event determination dates:</b>	Quarterly following the valuation date
<b>Initial price:</b>	The closing price of an underlying share as of the valuation date
<b>Maturity date:</b>	03 August 2021
<b>Valuation date:</b>	03 August 2018
<b>Worst performing share:</b>	For a given date, the underlying share with the worst performance between the initial price and the current price

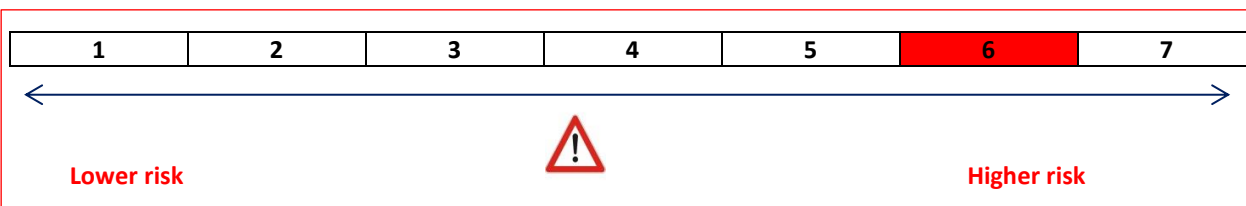
#### Intended retail investor

This product is intended to be offered to retail investors who fulfil all of the criteria below:

1. they have prior experience in investing in derivative products;
2. they can understand the interaction between the conditional payments under the product and the underlying shares' market performance;
3. they can afford to have their invested capital locked in for the full term of the product;
4. they can afford to lose part or all of the capital invested in the product;
5. they can understand the essence of extraordinary events, and comprehend the negative effect that such events can have on the product's financial result.

#### What are the risks and what could I get in return?

##### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements on the market or because we are not able to pay you. We have classified this product as 6 out of 7, which is an over aggressive risk class and rates the potential losses from product performance at a high level. ### **How long should I hold it and can I take money earlier?**

**Recommended holding period:** 36 months

The product aims to provide you with the return described under "What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.

You, however, have an option to terminate the product early. In case you do so you will, within 5 (five) business days upon the proposed early termination date receive the early termination amount equal to 65% of the Notional multiplied by the lesser of (a) one; or (b) the ratio between the Worst Performing Share's Current Price and 100% of its initial value. The Brokercreditservice Structured Products Plc may at its own discretion increase the Early Termination Amount.
