- You are looking for **income paid Quarterly following the valuation date, linked to the performance of the underlying assets Futu Hldgs Ltd, Lucid Group Inc, Roku Inc, Tencent Music Entmt Group, Shopify, Pinduoduo Inc.**
- You understand that on a **Quarterly** basis, on any given observation date, **if any one of the underlying assets is below the product of the corresponding coupon barrier price and their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least **the product of the corresponding coupon barrier price and** its initial level and the other underlying assets in the basket are at or above **the product of the corresponding coupon barrier price and** their initial level the previous missed coupons will be paid including any other coupon due
